**T**extile and Textile Product (TPT) is one of essential industries in Indonesia which contributes the largest state foreign exchange after oil and natural gas (Migas).

In American, Europe and Japan markets, Indonesian textile and its other textile products have owned proper position with market segments of 5 – 6% from total world export value although the competition of international textile products is very tight.

According to the observation of CDMI, the export of textile and textile products in 2000 – 2009 increased by 11.59% or rose by 3.4% on the average per annum. In 2009, the textile export value was US\$ 9.3 billion and estimated to have reached US\$ 10.5 billion in 2010 and expected to rise in 2011 because producers have prepared expenditure for machinery and new investment.
